

# Cuba Traveler Certification

You are required by the laws of the United States to provide a complete and accurate certification. The U.S. embargo against Cuba is mostly expressed in the Cuban Assets Control Regulations (“CACR”), which are found in [Part 515 of Title 31 of the U.S. Code of Federal Regulations](#). You should familiarize yourself with the CACR, in particular the provision authorizing your travel to Cuba, and consult a lawyer with any questions. Vacation Express is authorized to provide Cuba-related travel services only to U.S. travelers who (a) are traveling to Cuba for one of the 12 authorized travel categories, and (b) provide this certification. **Travel to Cuba for tourism remains strictly prohibited by U.S. law.**
